**A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY ENCOURAGING THE
ANCHORAGE POLICE DEPARTMENT TO PARTNER WITH THE ALASKA POLICE CORPS
PROGRAM**

WHEREAS, the Alaska Police Corps Program is designed to address violent crime by helping Alaskan law enforcement agencies increase the number of officers with advanced education and training assigned to community patrol; and

WHEREAS, the Alaska Police Corps is designed to motivate highly qualified young people to serve as police officers in Alaska in the areas and municipalities that need them the most; and

WHEREAS, the Corps does this by offering Federal scholarships on a competitive basis to college students who agree to serve where needed on community patrol for at least four years; and

WHEREAS, participation in this Program has been endorsed by the Anchorage Police Department Employee's Association (APDEA), and the Anchorage Police Department Administration; and

WHEREAS, this Program will benefit police departments throughout the State of Alaska as officers from around the State will be trained together in one academy and, upon return to their individual communities, will have already established a rapport and communications link among officers throughout Alaska; and

WHEREAS, the Police Corps Program is funded entirely by the Justice Department and implemented at no additional cost to Anchorage tax payers.

NOW, THEREFORE, the Anchorage Assembly resolves:

That the Assembly encourages the Anchorage Police Department to partner with the Alaska Police Corps Program.
