THE ANCHORAGE ASSEMBLY RESOLVES

<u>Section 1.</u> That a loan not to exceed Two Million Two Hundred Thousand Dollars (\$2,200,000) be hereby authorized from the Areawide General Fund (101) Cash Pool to the Anchorage Senior Center (ASC).

21 Section 2. That a sum not to exceed Two Million Two Hundred
22 Thousand Dollars (\$2,200,000) is hereby appropriated from the Areawide General Fund
23 (101) General Cash Pool to the Areawide Capital Improvements Fund (401), Project

25 That the Cash Pool loan and interest at general cash pool Section 3. 26 interest rates will be repaid as follows: A lump sum payment of Three Hundred Eighty-27 Four Thousand Five Hundred Dollars (\$384,500) from ASC within sixty days (60) of the 28 effective date of approval of this resolution; twenty-five (25) monthly installments of 29 Thirty Thousand Eight Hundred Dollars (\$30,800) from ASC commencing January 1, 30 2002 along with an amount from ASC to cover interest expense due on the last 31 scheduled monthly payment date; and annual contributions of Three Hundred Forty-32 Eight Thousand Five Hundred Dollars (\$348,500) from the Department of Health and 33 Human Services, Fund (101), to ASC in 2001 and, subject to appropriation, the same 34 amount in 2002 and 2003. 35
