A RESOLUTION APPROPRIATING ANNUAL ENTITLEMENT GRANTS FROM THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT IN THE AMOUNT OF TWO MILLION THREE HUNDRED FORTY-FOUR THOUSAND DOLLARS (\$2,344,000) FOR THE COMMUNITY DEVELOPMENT BLOCK GRANT, ONE MILLION SEVENTY-TWO THOUSAND DOLLARS (\$1,072,000) FOR HOME INVESTMENT PARTNERSHIP PROGRAM, AND EIGHTY THOUSAND DOLLARS (\$80,000) FOR EMERGENCY SHELTER GRANTS AND APPROPRIATING SAID FUNDS TO THE FEDERAL CATEGORICAL GRANTS FUND (241).

WHEREAS, the Municipality of Anchorage has submitted its annual application and *2001 Action Plan* of the *2000-2002 Consolidated Housing and Community Development Plan* to the U.S. Department of Housing and Urban Development, outlining the program of activities to be undertaken with Community Development Block Grant (CDBG), Home Investment Partnership (HOME) Program, and Emergency Shelter Grant (ESG) funds; and

WHEREAS, throughout the development of said application and Action Plan, the Municipality of Anchorage actively sought participation of residents and representatives of lower income Anchorage neighborhoods, including community councils, and

WHEREAS, public testimony on said application and Action Plan was heard before the Housing & Neighborhood Development Commission, and

WHEREAS, the Anchorage Municipal Assembly adopted the *2001 Action Plan* on July 24, 2001

NOW, THEREFORE, the Anchorage Assembly Resolves:

Section 1. That the subject grants from the United States Department of Housing and Urban Development (HUD) for the FFY01 allocation of Community Development Block Grant funds, in the amount of two million three hundred forty-four thousand dollars (\$2,344,000), the FFY01 allocation of HOME Investment Partnership funds, in the amount of one million seventy-two thousand dollars (\$1,072,000), and FFY01 allocation of Emergency Shelter Grant funds in the amount of eighty thousand dollars (\$80,000), are hereby appropriated, with final approval received from HUD on October 16, 2001, to the Federal Categorical Grant Fund (241) for use in activities under the CDBG, HOME and ESG programs.

Section 2. That the allocation of said grant funds will be based on the activities outlined in the attached Assembly Memorandum, and in the *2001 Action Plan* of the

2000-2002 Consolidated Plan, which incorporates Anchorage's Continuum of Care. Accounting information is outlined in the attached Assembly Memorandum, Attachment A.

Section 3. This resolution shall take effect immediately upon passage and approval by the Anchorage Assembly.
