AN ORDINANCE SUBMITTING TO THE QUALIFIED VOTERS RESIDING IN THE BIRCH TREE/ELMORE LIMITED ROAD SERVICE AREA AT THE REGULAR MUNICIPAL ELECTION APRIL 2, 2002, A BALLOT PROPOSITION APPROVING THE CONTINUATION OF SAID LIMITED ROAD SERVICE AREA FOR AN ADDITIONAL PERIOD OF THREE YEARS. ANCHORAGE MUNICIPAL CODE SECTIONS 27.20.200 AND 27.30.290.

WHEREAS THE Birch Tree/Elmore Limited Road Service Area was created by Anchorage Ordinance 81-117; and

WHEREAS a showing of interest in continuing said limited road service beyond December 31, 2002 has been made by persons residing in said limited road service area; now therefore,

THE ANCHORAGE ASSEMBLY ORDAINS:

Section 1. That a ballot proposition in substantially the following form shall be submitted to the qualified voters residing in the Birch Tree/Elmore Limited Road Service Area at the regular Municipal election on April 2, 2002:

Shall the existence of the Birch Tree/Elmore Limited Road Service area be continued for an additional period of three (3) years after December 31, 2002 until December 31, 2005?

4 Section 2. That Section 27.20.200 of the Anchorage Municipal Code is hereby amended to read  
5 as follows:  
6

7 Pursuant to section 27.10.050, there is established a board of supervisors to administer  
8 the Birch Tree/Elmore Limited Road Service Area. The board shall consist of five members  
9 elected for staggered terms. [THE SERVICE AREA WILL EXPIRE ON DECEMBER 31, 2002,  
10 UNLESS IT IS EXTENDED BY VOTE IN THE AREA AFFECTED AT THE REGULAR  
11 ELECTION OF APRIL 2002.]  
12

13 Section 3. That Section 27.30.290 of the Anchorage Municipal Code is hereby amended to read  
14 as follows:  
15

16 There is a limited road service area within the municipality known as the Birch  
17 Tree/Elmore Limited Road Service Area to provide limited road maintenance and repair to the  
18 area described on the map located in Section 27.30.700.  
19

20 Limited road maintenance and repair within the service area shall commence on  
21 January 2, 1982 and shall end on December 31, [2002] 2005 unless the service area is extended  
22 by an affirmative vote in the area affected at the regular election of April [2002] April 2005.  
23 The mill rate for the service area shall not exceed 1.5 mills in any calendar year.  
24

25 Section 4. Except for Section 3, this ordinance shall become effective upon passage and  
26 approval. Section 3 and the proposition contained in Section 1 shall become effective upon  
27 certification of the regular election on the proposition called for by this ordinance, but only if  
28 that proposition is approved by a majority of the qualified voters voting on the proposition.
