ANCHORAGE, ALASKA AO NO. 2002-<u>55</u>

AN ORDINANCE AMENDING ANCHORAGE MUNICIPAL CODE SECTION 27.20.110 TO SUNSET THE GIRDWOOD PUBLIC SAFETY BOARD AT THE END OF ITS CURRENT MEMBER'S TERMS AND REESTABLISHING THE GIRDWOOD BOARD OF SUPERVISORS AS THE ELECTED BOARD OF SUPERVISORS FOR ALL GIRDWOOD VALLEY SERVICE AREA SERVICES.

WHEREAS, there are currently two boards of supervisors for the Girdwood Valley Service Area ("GVSA"), namely the Girdwood Board of Supervisors ("GBOS") and the Girdwood Public Safety Board, ("GPSB") each with five elected members; and

WHEREAS, the membership of the two boards of supervisors overlaps because one qualification for election to the GPSB is that three members must also be members of the GBOS, effectively limiting the election to only two members who are not required to be members of the GBOS; and

WHEREAS, the supervisory authority over services provided in the GVSA is now split between two boards of supervisors and there is the desire to return to the structure and authority of the former board of supervisors; now therefore,

THE ANCHORAGE ASSEMBLY ORDAINS:

Without further action of the Assembly, the Girdwood Public Safety Board shall automatically cease to exist upon the expiration of the terms of its current members or the resignation of all currently serving members of the Girdwood Public Safety Board, whichever occurs first, and the Girdwood Board of Supervisors shall be reconstituted as provided in Section 2. of this ordinance.

To implement Section 1. of this ordinance, Anchorage Municipal Code subsection Section 2: 27.20.110C. is hereby repealed effective immediately upon the passage and approval of this ordinance and subsections 27.20.110A. and 27.20.110B. are hereby amended, effective upon the occurrence of the event specified in section 1. of this ordinance, to read as follows:

27.20.110 Girdwood Valley Service Area board of supervisors.

A. There is established a board of supervisors for the Girdwood Valley Service Area consisting of five persons elected in accordance with the provisions of this The board shall be constituted and shall function in the manner prescribed in this chapter in the exercise of fire prevention and protection, street construction and maintenance, solid waste collection, and parks and recreation services.

- THERE IS ESTABLISHED A PUBLIC SAFETY BOARD FOR THE IB. GIRDWOOD VALLEY SERVICE AREA CONSISTING OF FIVE MEMBERS, THREE MEMBERS OF WHICH SHALL ALSO BE MEMBERS OF THE GIRDWOOD VALLEY SERVICE AREA BOARD OF SUPERVISORS AND TWO MEMBERS OF WHICH SHALL NOT BE MEMBERS OF THE GIRDWOOD VALLEY SERVICE AREA BOARD OF SUPERVISORS, ALL OF WHOM SHALL BE ELECTED IN ACCORDANCE WITH THE PROVISIONS OF THIS CHAPTER. THE BOARD SHALL BE CONSTITUTED AND SHALL FUNCTION IN THE MANNER PRESCRIBED IN THIS CHAPTER IN THE EXERCISE OF SERVICE AREA FIRE PROTECTION SERVICES.]
- THIS ORDINANCE WILL SUNSET ON THE THIRD ANNIVERSARY OF ITS IC. PASSAGE UNLESS CONTINUED BY ASSEMBLY ACTION.

Section 3. The Girdwood Public Safety Board and the Girdwood Board of Supervisors will coordinate their actions and communicate regularly with one another regarding their activities, findings and decisions to keep each other currently informed.

Section 4. This ordinance shall become effective immediately upon its passage and approval by the Assembly.
