ANCHORAGE, ALASKA AO NO. 2002-59

AN ORDINANCE OF THE MUNICIPALITY OF ANCHORAGE CREATING SPECIAL ASSESSMENT DISTRICT 2R02, STREET UPGRADES TO FALLING WATER DRIVE AND WHITE WATER CIRCLE, AND DETERMINING TO PROCEED WITH PROPOSED IMPROVEMENTS THEREIN.

WHEREAS, a petition for creation of a Special Assessment District to upgrade Falling Water Drive and White Water Circle has been received by the Municipality and has been signed by sufficient and proper petitioners. The purpose of the petition is to form a Road Improvement District (RID) to upgrade these residential streets, as shown on the attached map. Neither street has been constructed to municipal standards; and

WHEREAS, the aforementioned public improvements are necessary and of benefit to the following described properties, also shown on the attached map:

- Lots 4 through 6 of Block 5 of the River View Estates Subdivision
- Lots 9 through 10 of Block 5 of the River View Estates Subdivision
- Lots 1 through 3 of Block 8 of the River View Estates Subdivision
- · Lots 7 through 12 of Block 8 of the River View Estates Subdivision; and

WHEREAS, the improvements have an estimated assessable cost of \$32,000. This estimate was presented to property owners, as shown in the attached RID Petition Roll; and

WHEREAS, project funding is available from the Chugiak Birchwood Eagle River Rural Road Service Area (CBERRRSA) capital mill levy fund; now therefore.

THE ANCHORAGE ASSEMBLY ORDAINS:

<u>Section 1</u>. There is established Special Assessment District No. 2R02 comprised of the property previously herein described.

<u>Section 2</u>. The Municipality shall proceed with the aforementioned public improvement.

<u>Section 3</u>. Costs assessed to benefited parcels shall be the lesser amount of: (1) actual project costs; (2) the last approved estimate plus ten percent (10%); or (3) the construction contract costs plus twenty percent (20%) for non-contract costs, plus actual acquisition costs.

<u>Section 4</u>. Assessments levied pursuant to this Ordinance shall be calculated based upon the area (square feet) of the lots adjacent to the right-of-way. The Assembly finds that assessments calculated on this basis are proportionate to the benefit received from and the burden imposed upon the improvement.

<u>Section 5</u>. The Mayor shall cause proper account of all costs to be kept of the public improvement and, after completion of the improvement, shall have an assessment roll prepared and presented to the Assembly for the purpose of assessing the cost of the improvement to the benefited properties.

<u>Section 6</u>. The Mayor forthwith shall cause this Ordinance to be recorded in the office of the Anchorage District Recorder.

<u>Section 7</u>. This ordinance shall be effective immediately upon its passage and approval.



> A petition to upgrade Falling Water Drive and White Water Circle was approved by property owners representing over 50% of the estimated assessable cost. The petition results showed eight property owners representing 61.77% of the assessable cost in favor, two property owners representing 13.23% opposed, and four property owners representing 25.00% not responding.

The purpose of the petition is to form a Road Improvement District (RID) to upgrade Falling Water Drive and White Water Circle. The roads will be accepted for municipal maintenance upon completion of the upgrades.

The estimated cost of the project is \$32,000. Project funding is available from the Chugiak Birchwood Eagle River Rural Road Service Area (CBERRRSA) capital mill levy. Construction is proposed in 2002 by the CBERRRSA maintenance contractor. Assessable costs are estimated at \$32,000.
