AN ORDINANCE OF THE ANCHORAGE ASSEMBLY ENACTING A NEW CHAPTER
3.99 TO THE ANCHORAGE MUNICIPAL CODE, ADOPTING THE ANCHORAGE
MUNICIPAL LIBRARIES EXHIBIT POLICY RECOMMENDED BY THE MUNICIPAL
LIBRARY ADVISORY BOARD ON JULY 31, 2001, AND REPEALING MUNICIPAL
OPERATING POLICY/PROCEDURE 30-1 PROMULGATED BY THE MAYOR ON MAY
14, 2002

The Anchorage Assembly ordains:

Section 1: That a new Chapter 3.99 is enacted to the Anchorage Municipal Code
as follows:

Chapter 3.99

PUBLIC EXHIBITS IN MUNICIPAL LIBRARIES

3.99.10 Placement of Public Exhibits in Municipal Libraries

The placement of public exhibits in Municipal libraries shall be
governed by the Anchorage Municipal Libraries Exhibit Policy, dated
July 31, 2001, as recommended by the Municipal Library Advisory
Board. A copy of this policy shall be filed and made available to the
public upon request at Municipal libraries and the Municipal Clerk's
Office.

Section 2: That Municipal Operating Policy/Procedure, dated May 14, 2002, as
promulgated by the Mayor, is hereby repealed.
