AN ORDINANCE OF THE ANCHORAGE MUNICIPAL ASSEMBLY REPEALING ANCHORAGE MUNICIPAL CODE SECTION 2.20.090, EXPENDITURE OF ASSEMBLY FUNDS, APPROVAL BY ASSEMBLY

THE ANCHORAGE ASSEMBLY ORDAINS:

<u>Section 1:</u> That Anchorage Municipal Code Section 2.20.090, Expenditure of Assembly funds, approval by assembly, is repealed in its entirety.

[2.20.090 EXPENDITURE OF ASSEMBLY FUNDS, APPROVAL BY ASSEMBLY.

- A. EXCEPT FOR BUDGETED PAYROLL, TRAVEL AND ASSEMBLY INTERN EXPENSES, NO EXPENDITURE OF APPROPRIATED FUNDS FROM ANY ACCOUNT SHALL BE MADE IN AN AMOUNT OF \$2,000.00 OR MORE BY OR AT THE DIRECTION OF ANY ASSEMBLY MEMBER WITHOUT PRIOR APPROVAL BY THE ASSEMBLY.
 - 1 FOR THE PURPOSES OF THIS SECTION, AN EXPENDITURE SHALL MEAN:
 - A. ANY TRANSFER OF ASSEMBLY FUNDS BETWEEN ASSEMBLY ACCOUNTS OR ASSEMBLY BUDGET CATEGORIES; AND
 - B. ANY "CONTRACT" AS THAT TERM IS DEFINED BY AMC SECTION 7.10.010 AND INCLUDES ANY PURCHASE ORDER OR OTHER PURCHASE OF SUPPLIES, EQUIPMENT OR SERVICES AND ANY COMMITMENT FOR SUCH AN EXPENDITURE. ALL SUCH EXPENDITURES ARE SUBJECT TO AND SHALL COMPLY WITH THE RESTRICTIONS OF AMC SECTION 6.30.080 AND APPLICABLE PROVISIONS OF TITLE 7.
- B REQUESTS FOR ASSEMBLY APPROVAL OF EXPENDITURES UNDER THIS SECTION SHALL IDENTIFY AND JUSTIFY THE NEED, PURPOSE, AND INTENDED USE OF EXPENDITURE AND DEVIATIONS, IF ANY, FROM THE APPROVED MUNICIPAL BUDGET. CERTIFICATIONS REQUIRED BY SECTION 6.30.050 (CERTIFICATION OF FUNDS AVAILABILITY) SHALL ACCOMPANY EACH REQUEST FOR ASSEMBLY APPROVAL OF EXPENDITURES UNDER THIS SECTION.]

Section 2: That this ordinance is effective immediately upon passage and approval.
