#### **PUBLIC SECTOR ECONOMIC EFFECTS:**

In terms of the McKay Building Project, it is estimated that \$70,000 in plan review and permit fees would be waived. If the project does not go forward, the Municipality would have to pay approximately \$3,000,000 for demolition of the building.

It is difficult, at this time, to estimate the dollar amount for future plan review and permit fees that would be waived for projects built within a deteriorated area.

#### PRIVATE SECTOR ECONOMIC EFFECTS:

Although approximately \$70,000 of revenue would be lost, the City would still save many times that amount because the building would otherwise have to be demolished.
