AN ORDINANCE OF THE ANCHORAGE MUNICIPAL ASSEMBLY AMENDING AMC 6.10.040 RELATING TO THE DATE THE GENERAL GOVERNMENT CAPITAL BUDGET/CAPITAL PROGRAM WILL BE ADOPTED BY THE ASSEMBLY.

THE ANCHORAGE ASSEMBLY ORDAINS

Section 1: That AMC 6.10.040 is amended to read as follows:

6.10.040 Submittal and adoption of municipal operating and capital budget.

- A. At least 120 days before the end of the fiscal year the mayor shall submit to the assembly the following:
 - A preliminary general government capital budget/capital program and utilities capital budget/capital program.
 - 2. Proposed utility business plans and update to utility strategic plans.
 - 3. Preliminary general government revenue plan, tax limitation, and administration service priorities.
 - 4. Major departmental consolidations, reorganizations or establishments necessitating changes to chapter 3.10 or 3.20, pertaining to executive organization, and required by proposed budgets for the next fiscal year.
 - B. The general government capital budget/capital program will be adopted <u>at least 21 days prior to the end of the fiscal year of the municipality</u>
 [BY NOVEMBER 10 OF EACH FISCAL YEAR].
 - C. The proposed operating and capital budget shall be submitted to the assembly as provided in Charter section 13.03
- <u>Section 2</u>: This ordinance shall become effective upon passage and approval.
