Section 1. Anchorage Municipal Code subsection 9.28.030D. is hereby amended to read as follows:

Subject: AO 2002- 175 ; AN ORDINANCE AMENDING ANCHORAGE MUNICIPAL CODE SUBSECTION 9.28.030D., REGARDING MINIMUM SENTENCING FOR FAILURE TO HAVE VEHICLE INSURANCE, TO CORRECT THE SENTENCING STRUCTURE.

The current sentencing structure for failure to have insurance or other security is graduated to increase the jail time, fine and impound or forfeiture of the vehicle for persons previously convicted. Each conviction will automatically increase the minimum sentence possible for subsequent offenses. In order for this graduation to work as intended, a minor correction is necessary to subsection D.
