Subject: AO 2002-184 Compensation of Election Commission Members

For many years, the compensation of election poll workers has been \$7.50 per hour, and compensation for Municipal Election Commission members has been \$10.00 per hour. Recently, however, the State Legislature increased the compensation of election poll workers to \$9.50 per hour - the amount that the Municipality will now pay for Municipal elections. Given this increased compensation for poll workers, this proposed ordinance increases the compensation of our Municipal Election Commission members from \$10.00 per hour to \$12.00 per hour - maintaining the historic \$2.50 difference in compensation between poll workers and Commission members.

Approval of AO 2002-184 is recommended.
