A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING THE SUM OF TWENTY THOUSAND DOLLARS (\$20,000) FROM THE STATE OF ALASKA, ALCOHOLIC BEVERAGE CONTROL BOARD TO THE STATE CATEGORICAL GRANTS FUND (231), ANCHORAGE POLICE DEPARTMENT, FOR AN ALCOHOL SALES TO MINORS ENFORCEMENT PROGRAM.

THE ANCHORAGE MUNICIPAL ASSEMBLY RESOLVES:

Section 1. That the sum of TWENTY THOUSAND DOLLARS (\$20,000), is appropriated from the State of Alaska, Alcoholic Beverage Control Board to the State Categorical Grants Fund (231), Anchorage Police Department, for an Alcohol Sales To Minors Enforcement Program.

Section 2. This resolution shall take effect immediately upon passage and approval.

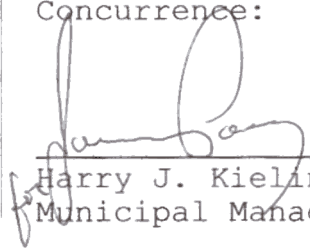

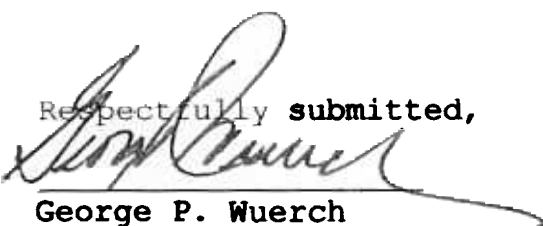
