Supplemental Appropriation to the Workforce Investment Act Title IB Youth Program for Program Year 2001

The Administration requests approval of the attached resolution to appropriate the supplemental funding of Thirty Four Thousand Six Hundred Forty Seven Dollars (\$34,647.00) to the State Categorical Grants Fund (231) from the Alaska Department of Labor and Workforce Development for the PY 2001 Workforce Investment Act Title IB Youth Program within the Planning Department. The supplemental funding to the grant will fund program from July 1, 2001 through June 30, 2002.

These funds will be used to create and maintain a seamless continuum of educational and career development opportunities and incentives that assist youth in selecting, pursuing, and obtaining careers that result in self-sufficiency. Operating under a consortium agreement between the Municipality of Anchorage and the Matanuska-Susitna Borough, training and employment opportunities are provided to qualified individuals through the combined service area.






