A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING THIRTY-EIGHT THOUSAND SEVEN HUNDRED DOLLARS (\$38,700) FROM THE STATE OF ALASKA, DEPARTMENT OF COMMUNITY AND ECONOMIC DEVELOPMENT, TO THE STATE CATEGORICAL GRANT FUND (231) FOR CONTINUING IMPLEMENTATION OF THE ANCHORAGE COASTAL MANAGEMENT PROGRAM.

THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1. That a sum of THIRTY-EIGHT THOUSAND SEVEN HUNDRED DOLLARS (\$38,700), received from the State of Alaska, Department of Community and Economic Development, is hereby appropriated to the State Categorical Grant Fund (231) for the continuing implementation of the Anchorage Coastal Management Program.

Section 2. This resolution shall take effect immediately upon passage and approval.

Subject: AR 2002- 21 Coastal Management Program Grant for FY 2002

For the past 21 years, with the endorsement of the Municipal Assembly, the Planning Department has been implementing the Anchorage Coastal Management Program. During this period, the State of Alaska has provided funding to the Municipality for staff support for required Coastal District tasks under the Coastal Management Program and occasionally for additional special projects. Such special activities have included wetlands mapping, wetland fill permit coordination, and land use planning for areas within Anchorage's coastal zone boundary.

The State of Alaska, Department of Community and Economic Development (formerly Community and Regional Affairs), has recently forwarded to the Municipality a Coastal Management Program Grant agreement for FY 2002. This grant covers expenditures from July 1, 2001, through June 30, 2002. The FY 2002 Grant provides \$38,700 to the Municipality for ongoing funding of wetland project review and permit coordination, field monitoring, and other activities associated with the Anchorage Coastal Management Program, work traditionally performed by the Planning Department staff. The required match of \$11,610 will be provided by in-kind staff support from the Physical Planning Division.

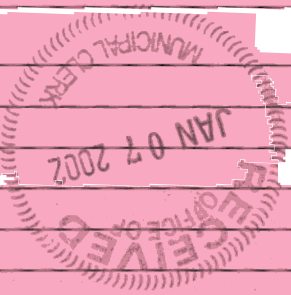
