The Anchorage Police Department Crisis Intervention Response Team (CIRT) is a special force of 26 highly trained, experienced, and motivated officers who are charged with managing the most difficult and dangerous situations encountered by law enforcement in Anchorage. Because the CIRT team is the community's strongest response to the most violent, armed, and threatening criminals, it is of the utmost importance that the equipment provided the Team is of top quality and simply the best equipment available. Unfortunately, the rifle inventory is old and in dire need of replacement.

The attached resolution, if approved, will appropriate \$50,000 from the Police Service Area Fund Balance to the Police Department to standardize and significantly enhance the weapons by replacing an aging tactical rifle inventory with new firearms.
