45 46 APPROPRIATING \$21,000 FROM AREAWIDE GENERAL FUND (101) BALANCE

TO PROVIDE FUNDING FOR THE MUNICIPAL RECYCLING PROGRAM

Prior to 1998, the Municipality of Anchorage participated in a recycling program with the Anchorage Recycling Center at no cost. In 1998, the Recycling Center negotiated a contract with the Municipality which requires the Municipality to pay a fee for having recyclable material picked up at various General Government facilities. From 1998 to 2001, the funding each year for these services (\$11,800) has been appropriated to the Facility Management budget. In addition, during the 2001 1st quarter budget revision process, Assemblymember Abney discovered that there were several departments who were not participating in the program because of funding issues, and added an additional \$9,000 to ensure that all departments had the opportunity to participate. The Program has grown and virtually every department and/or divisions are now participating, including the Utilities at its own expense.

Unfortunately, during the 2002 budget process, the funding was eliminated and there is currently no money available to continue the contract for this year. The Recycling Program is a worthwhile program that contributes to safeguarding our environment and we, as government, should set the example to promote recycling and encourage the participation of every citizen within this community.
