

In addition, the design and the construction of the horseshoe shaped bar as depicted on the floor plan and as actually constructed is such that no more than eighteen (18) bar stools can be accommodated at the horseshoe bar. Any change in the size of the horseshoe bar which results in any additional seating being accommodated at the horseshoe bar, shall require a modification to the conditional use permit.

1 5. The applicant shall demonstrate compliance with a Liquor "Server Awareness Training Program approved by the State of Alaska Alcoholic Beverage Control 2 Board, such as or similar to the program for Techniques in Alcohol Management 3 4 (T.A.M.).5 6 6. The use of the property by any person for the permitted purposes shall comply with 7 all current and future federal, state and local laws and regulations, including but not 8 limited to laws and regulations pertaining to the sale, dispensing, service and 9 consumption of alcoholic beverages and the storage, preparation, sale, service and consumption of food. The owner of the property, the licensee under the Alcoholic 10 11 Beverage Control license and their officers, agents and employees shall not 12 knowingly permit or negligently fail to prevent the occurrence of illegal activity on 13 the property 14 15 7. A copy of the conditions imposed by the Assembly in connection with this conditional use approval shall be maintained on the premise at a location visible to 16 17 the public. 18 The approved conditional use is reflected on the following plans: 19 8. 20 21 Site and Floor Plan for Applebee's Restaurant, Anchorage Alaska; Sheet No. a. 22 A-1; Scale 1" = 20'; dated July 1, 2001; prepared by Rim Architects. 23 Section 4. Failure to comply with the conditions of this conditional use permit shall 24 25 constitute grounds for its modification or revocation. 26 Section 5. Apple Alaska LLC has made application for a new conditional use permit

3 for an alcoholic beverages conditional use in the B-3 SL District for

4 Applebee's Restaurant per AMC 21.40.180.D8 and an alcoholic beverages

Beverage Dispensary license. The restaurant will occupy 2,800 square

6 feet of a 5,635 square foot building that is under construction at 7611

DeBarr Road.

The applicant filed an application with the Alcoholic Beverage Control Board on December 26, 2001 to transfer an existing beverage dispensary license number 2456 held by Norman H. Dahl. The license was issued to

the Rock U Bar located at 6119 Old Seward Highway.

The Northeast Community Council approved this location for a conditional use for a beverage dispensary use and transfer of a beverage dispensary liquor license with restrictions. The vote was 27 in favor, 10 opposed. The restrictions include (1) a liquor to food ratio of 25%/75% except on school days the ratio shall not exceed 10% to 90% between the hours of 11 AM and 4 PM, (2) fixed seating at the bar shall not exceed 18 seats.

Alaska Statute 04.11.410, Restriction of Location Near Churches and Schools, restricts beverage dispensary and package store licenses from being located in a building the public entrance of which is within 200-feet of the public entrance of a church building, or from being located within 200-feet of school grounds. There are no churches or schools within 200 feet of the proposed Applebee's Restaurant. There are three elementary schools in the Muldoon area: Creekside, Muldoon and Chester Valley, all of which are more than one-half mile away.

AMC 21.50.160.B asks that a list of all alcohol licenses located within a minimum of 1,000 feet of the proposed conditional use be provided. There are two restaurant/eating place licenses and one beverage dispensary license within 1,000-feet of the proposed Applebee's Restaurant. Approving this beverage dispensary license would add a second beverage dispensary license.

This conditional use for alcoholic beverages in the B-3 SL District for a 1 beverage dispensary use and license generally meets the required 2 3

standards of Title 21.


