
A REVISION TO THE 2001 GENERAL GOVERNMENT OPERATING BUDGET APPROPRIATING ONE THOUSAND THREE HUNDRED DOLLARS (\$1,300) FROM REVENUE RECEIVED FROM THE U.S. EQUAL EMPLOYMENT OPPORTUNITY COMMISSION AS REIMBURSEMENT TO THE EQUAL RIGHTS COMMISSION FOR TRAVEL TO AND ATTENDANCE AT THE FY 2001 EEOC – FEPA TRAINING CONFERENCE.

THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1. The sum of One Thousand Three Hundred Dollars (\$1,300) is hereby appropriated from revenue received from the U.S. Equal Employment Opportunity Commission to the Areawide Operating Fund (101), Equal Rights Commission 2001 Operating Budget for reimbursement to the Equal Rights Commission for travel to and attendance at the FY 2001 EEOC – FEPA Training Conference; and

SUBJECT: Resolution AR 2002- 66, Appropriation of One Thousand Three Hundred Dollars of revenue received from the U.S. Equal Employment Opportunity Commission to the Areawide Operating Fund (101), Equal Rights Commission 2001 Operating Budget as reimbursement to the Equal Rights Commission for travel to and attendance at the FY 2001 EEOC – FEPA Training Conference.

Assembly Resolution AR No. 2002- 66 requests appropriation of one thousand three hundred dollars (\$1,300) from revenue received from the U.S. Equal Employment Opportunity Commission to the Equal Rights Commission Department's 2001 operating budget in reimbursement of travel expenses required by the travel to and attendance at the FY 2001 EEOC – FEPA Training Conference.

The Equal Rights Commission has a contract with the U.S. Equal Employment Opportunity Commission to enforce federal Title VII in cases that are jurisdictional to both agencies. The U.S. Equal Employment Opportunity Commission requires that a staff person from the Equal Rights Commission attend the EEOC Training Conference annually and provides reimbursement of travel expenses to make that possible. The U.S. Equal Employment Opportunity Commission gave the Municipality of Anchorage Equal Rights Commission \$1,300 in 2001 in reimbursement of the travel expenses to Miami Beach, Florida for the June 26-29, 2001 conference.
