A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY MAKING A SITE IN THE 10 VICINITY OF RUTH ARCAND PARK AVAILABLE TO THE SIMONIAN LITTLE LEAGUE IN 2004

WHEREAS, private property historically used by the Simonian Little League for youth 15 baseball will no longer be available to the League after the Summer season of 2003; and

WHEREAS, the Municipality has traditionally made its property available to the Little 18 League for youth baseball because use of Municipal lands for Little League programs benefits 19 all of the citizens of Anchorage; and

WHEREAS, land situated slightly North of Site 31 of the Abbott Loop/Simonian Community Park Report prepared by Land Design North, located within Ruth Arcand Park, is currently under Municipal ownership and can be made available for relocation of the Simonian Little League fields by Summer 2004 without further acquisition costs; and

WHEREAS, 90% or more of this site is located on uplands, and has a grade of less than 10%, as recommended in the Study; and

WHEREAS, the site has a long list of virtues which include: site is already under public 30 ownership; site has access via an existing major arterial roadway, including a pedestrian underpass connecting adjacent residential neighborhoods and established bike trails; proximity 32 to two public schools, thereby providing supplemental play fields for use by the Anchorage 33 School District during the school year; existing water facilities for field maintenance; minimal impact on other recreation users; existing and compatible zoning (PLI); and minimal noise and 35 traffic impacts to surrounding neighborhoods; and

WHEREAS, the required public process for site selection and approval of a site plan for 38 relocation of ball fields in the vicinity of Ruth Arcand Park is identical to that required for construction of the fields in Bicentennial Park and is no more time consuming; and

WHEREAS, the Municipality currently has \$100,000 available to assist the Simonian Little 42 League and, in partnership with the League, will explore additional public and private funding for construction of the fields in the vicinity of Ruth Arcand Park.

NOW THEREFORE, the Anchorage Assembly resolves:

Section 1: That the Municipality shall make approximately fifteen (15) acres of public lands, located near Site 31 of the Abbott Loop/Simonian Community Park Report prepared by 5 Land Design North Study, available for the construction of four new Little League ball fields and accessory uses. The site shall be available for use by the Simonian Little League no later than the Summer of 2004.

Section 2: That upon passage of this resolution, the Mayor shall prepare a Development 10 Plan and project budget for relocation of the Simonian Little League fields to an area located 11 near Site 31, within Ruth Arcand Park. The Plan shall accommodate four Little League ball fields 12 and an area sufficient for spectators, concessions, batting cages, and parking. 13 requirements may be supplemented by existing parking available at Spring Hill Elementary 14 School upon agreement by the Anchorage School District.

Section 3: That the Assembly intends to appropriate \$100,000 of currently available 17 funding, an additional \$600,000 from the proceeds of a Park Bond, if approved by the voters in 18 April, 2002 or thereafter, and such additional funding as recommended by the Mayor in the 19 project budget toward construction of the ball fields. The Simonian Little League shall provide 20 additional resources in terms of volunteer time, materials, and labor toward the construction of 21 the ball fields.

Section 4: That Municipal Codes and Regulations shall govern exact site selection. construction, and use of the ball fields under this resolution. The Mayor shall prepare and submit 24 25 to the Assembly such legislation, including appropriations measures that are necessary to carry 26 out the purpose of this resolution and to make the new ball fields available to the League for play by the Summer of 2004.
