That One Hundred Ninety Thousand dollars (\$190,000.00) of Cash Pool Interest Budget revenues earned on the CBERRSA Mill Levy Fund (419) is hereby appropriated to the CBERRSA Capital Improvement Program Mill Levy Fund (419) for budget year 2002 road drainage and capital improvement projects.
