A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE PROVIDING FOR THE APPROPRIATION OF TWO THOUSAND TWO HUNDRED THIRTY FOUR DOLLARS FROM DONATIONS AND FIVE THOUSAND DOLLARS FROM THE RASMUSON FOUNDATION TO THE MISCELLANEOUS OPERATIONAL GRANT FUND (261), CULTURAL AND RECREATIONAL SERVICES DEPARTMENT, FOR THE PURCHASE OF LIBRARY BOOKS AND MATERIALS AND THE PURCHASE OF LIBRARY BOOKS FOR THE LOUSSAC CHILDREN'S LITERATURE COLLECTION.

THE ANCHORAGE ASSEMBLY RESOLVES


Section 1. That the sum not to exceed TWO THOUSAND TWO HUNDRED THIRTY FOUR DOLLARS (\$2,234) in proceeds from numerous citizens' donations is hereby appropriated to the Miscellaneous Operational Grant Fund (261), Cultural and Recreational Services Department, for the purchase of library books and materials.

Section 2. That the sum not to exceed FIVE THOUSAND DOLLARS (\$5,000) in proceeds from a Rasmuson Foundation grant is hereby appropriated to the Miscellaneous Operational Grant Fund (261), Cultural and Recreational Services Department, for the purchase of library books for the Loussac Children's Collection

Section 3. That this resolution shall take effect immediately upon passage and approval.




