Improvements to Loretta French Ball Field Development Project,

Loretta French Park Equestrian Center and upgrades to various Eagle

River-Chugiak Parks.

The attached Assembly Resolution appropriates a contribution of \$47,720 from the Eagle River-Chugiak Park and Recreational Service Area Fund (162) Balance to the Eagle River-Chugiak Park and Recreational Service Area Capital Improvements Fund (462).

On February 11th, 2002 the Eagle River-Chugiak Parks and Recreation Board of Supervisors approved the use of Eagle River-Chugiak Park and Recreational-Service Area Fund Balance as a contribution for improvements to Loretta French Ball Field Development Project, the Loretta French Park Equestrian Center and supplies for other community based capital projects in the Eagle River-Chugiak area. The Loretta French Ball field Development Project includes two years of construction administration and inspection for both the on-going gravel extraction and continuing construction, including two additional ball fields, lighting, scoreboards, landscaping, paved parking, and project management fees. The Loretta French Park Equestrian area will have fill and grading completed to provide transition and access to riding pens and handicap staging areas. Various other community based capital projects will be supplied with materials for volunteer labor efforts to improve parks in the Eagle River-Chugiak area such as Schroeder Park pavilion refinishing, upgrades to Little League fields and cross country ski trails, and other park improvements.
