A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING
THE SUM OF ONE HUNDRED FOURTY FOUR THOUSAND ONE HUNDRED
EIGHTY DOLLARS (\$144,180) FROM THE STATE OF ALASKA,
DEPARTMENT OF TRANSPORTATION & PUBLIC FACILITIES, DIVISION OF
STATEWIDE PLANNING HIGHWAY SAFETY OFFICE AND SIXTEEN
THOUSAND TWENTY DOLLARS (16,020) AS A CONTRIBUTION FROM THE
2002 ANCHORAGE POLICE OPERATING BUDGET, ANCHORAGE
METROPOLITAN POLICE SERVICE AREA FUND (151) TO THE STATE
CATEGORICAL GRANTS FUND (231) FOR TH DUI .08 UNDER 21
ENFORCEMENT PROGRAM.


THE ANCHORAGE MUNICIPAL ASSEMBLY RESOLVES:

Section 1. That the sum of ONE HUNDRED FOURTY FOUR
THOUSAND ONE HUNDRED EIGHTY DOLLARS (\$144,180), is appropriated as a
grant from the State of Alaska, Department of Transportation & Public Facilities,
Division of Statewide Planning Highway Safety Office to the State Categorical Grant
Fund (231) for DUI .08 Under 21 Violation Enforcement.

Section 2. That the sum of SIXTEEN THOUSAND TWENTY DOLLARS
(\$16,020), is appropriated from the Anchorage Metropolitan Police Service Area Fund
(151), 2002 Anchorage Police Department Operating Budget as a contribution to the
State Categorical Grants Fund (231).

Section 3. This resolution shall take effect immediately upon passage
and approval.

Subject: Appropriation from the State of Alaska, Department of

Enforcement/Under 21 Enforcement Grant and local match
required. (\$160,200)

The Municipality of Anchorage has received a grant from the State of Alaska, Department of Transportation & Public Facilities, Division of Statewide Planning Highway Safety Office for increased enforcement of DUI .08 & Under 21 Violations. This grant will be used to support increased DUI .08 & Under 21 Enforcement patrols in the amount of \$160,200.

This grant will be used to pay officer overtime for traffic assignments specifically targeted for enforcement of DUI .08 & Under 21 Violations within the Municipality of Anchorage. Through increased awareness and enforcement of DUI .08 and Under 21 Violations the residents of Anchorage will experience safer roads and reduced traffic accident injuries.

A special condition of this grant is that the department provides matching funds. The total projected Municipal cost is \$16,020, which has been budgeted in the 2002 Operating Budget. This grant will begin March 1, 2002 and end September 30, 2002.




