A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY SUPPORTING ENACTMENT OF STATE LEGISLATION ALLOWING ISSUE OF SERIAL CATERS' PERMITS FOR PERIODIC EVENTS SUCH AS THE FIRST FRIDAY GALLERY WALK INVOLVING THE SERVING OF ALCOHOLIC BEVERAGES

WHEREAS, the First Friday Gallery Walk was started in 1994 by the Decker/Morris Gallery and the International Gallery of Contemporary Art; and

WHEREAS, the purpose of First Friday is to provide cultural enrichment to the citizens of Anchorage; and

WHEREAS, the First Friday Gallery Walk brings hundreds of people to Downtown Anchorage to spend money and time in art galleries, restaurants, and other retail businesses; and

WHEREAS, current Alaska State Statutes (AS 04) do not readily allow issue of appropriate permits or licenses for the serving of alcoholic beverages at events such as the First Friday Gallery Walk; and

WHEREAS, amendment to AS 04 could allow Downtown businesses to continue the successful once a month Friday Gallery Walk under the supervision of a responsible licenseeand under conditions that will protect the public interest.

NOW, THEREFORE, the Anchorage Assembly resolves:

<u>Section 1:</u> That the Anchorage Assembly urges the State Alcoholic Beverage Control Board and the Alaska Legislature to enact an amendment to AS 04 that would permit Downtown businesses to serve alcohol beverages in connection with the First Friday Gallery Walk through issue of serial caters' permit.

<u>Section 2:</u> That this resolution is effective upon passage and approval
