A RESOLUTION AUTHORIZING THE MUNICIPALITY TO GRANT ELECTRICAL EASEMENTS ACROSS A PORTION OF TRACT B-1A, MOUNTAIN AIR ESTATES SUBDIVISION ADDITION NO. 2, FOR THE RABBIT CREEK FIRE STATION, STATION NO. 10, LOCATED AT RABBIT CREEK ROAD AND MOUNTAIN AIR DRIVE, TAX CODE #017-211-34

WHEREAS, improvements within Tract B-1A, Mountain Air Estates Subdivision Addition No. 2 require electrical service provided by Chugach Electric Association, Inc. (CEA), in order to provide power to the Rabbit Creek Fire Station; and

WHEREAS, in order to install electrical facilities to the new addition, CEA requires two strip easements within Tract B-1A, as a condition of service; and

WHEREAS, the subject easements are found to be of no substantial monetary value to the Municipality; now therefore,

THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1. The Administration is authorized to grant the requested electrical easements to CEA in the following locations:

Two easements located within Tract B-1A, Mountain Air Estates Subdivision Addition No. 2, according to Plat 2000-118, on file in the office of the Anchorage District Recorder, Third Judicial District, State of Alaska, said easements more particularly described as follows:

Easement 1: A strip of land Twenty Feet (20') in width located within said Tract B-1A, the centerline of said strip more particularly described as follows: Commencing at the northwest corner of said Tract B-1A; thence S 16° 13' 40" W 10.41 feet coincident with the northwest property line to the True Point of Beginning; thence N 89° 59' 40" E 6.80 feet; thence S 03° 19' 29" E 92.61 feet; thence S 03° 50' 38" W 49.82 feet; thence S 08° 19' 55" W 42.99 feet to the end of said strip. Containing 3708.40 square feet more or less.


Easement 2: A strip of land Ten Feet (10') in width located within said Tract B-1A, the centerline of said strip more particularly described as follows: Commencing at the northwest corner of said Tract B-1A; thence S 16° 13' 40" W 41.00 feet coincident with the northwest property line to the True Point of Beginning; thence East 45.00 feet to the end of said strip. Containing 450 square feet more or less.

Assembly Resolution No. AR 2002-99 __, Regarding Authorization of the SUBJECT:

Municipality to Grant Electrical Easements to Chugach Electric Association, Inc., Across a Portion of Tract B-1A, Mountain Air Estates Subdivision, Addition No. 2, for the Rabbit Creek Fire Station, Station No. 10, Located at

Rabbit Creek Road and Mountain Air Drive, Tax Code #017-211-34

The Chugach Electric Association, Inc. (CEA) has been requested by the Municipality of Anchorage, Department of Project Management & Engineering to provide electrical service to the new addition of the Rabbit Creek Fire Station, within Tract B-1A, Mountain Air Estates Subdivision, Addition No. 2. The fire station is located at Rabbit Creek Road and Mountain Air Drive. Accordingly, CEA requires easements within the property site and identified as Strip 1 and Strip 2 on the attached Exhibit A.

Currently the septic system on Tract B-1A overlaps a portion of an existing electrical easement. In order to avoid the conflict with the septic system, CEA will install new underground facilities near the west property line in the newly described easement area (Strip 1). Additionally, CEA will realign the existing overhead electric line that brings power across Rabbit Creek Road to Tract B-1A. The pole in the northwest corner will be relocated to utilize the existing 10-foot by 30-foot anchor easement. The guy wires and anchors on the new pole will require a 45-foot long easement. A new anchor easement has been written to overlap and extend 15 feet beyond the existing anchor easement (Strip 2).
