A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING TWO HUNDRED TWENTY FIVE THOUSAND DOLLARS (\$225,000) AS A CONTRIBUTION FROM THE ALASKA CENTER FOR THE PERFORMING ARTS TO THE AREAWIDE GENERAL CAPITAL IMPROVEMENT PROGRAM FUND (401) FOR IMPROVEMENTS TO THE VOTH REHEARSAL HALL

WHEREAS, on November 3, 1998, the Anchorage Assembly adopted the Approved 1999 Capital Improvement Budget/Program (AO 98-153 (S) as amended), which included the ACPA Rehearsal Hall project; and

WHEREAS, on September 26, 2000 the Anchorage Assembly passed a resolution approving the Municipality's application for grants for State Fiscal Year 2002 under the Municipal Capital Project Matching Grant Program (AR 2000-26 as amended), including \$525,000 for the ACPA Rehearsal Hall; and

WHEREAS, on July 24, 2001, the Anchorage Assembly passed a resolution accepting and appropriating State Legislative Grants per Senate Bill 29 and agreeing to provide the local share required for grants issued under AS 37.06.090 (AR 2001-204) including \$525,000 for the ACPA Rehearsal Hall; and

WHEREAS, the Alaska Center for the Performing Arts has provided the required local share of \$225,000 in cash to match the State grant of \$525,000; now therefore,

THE ANCHORAGE ASSEMBLY HEREBY RESOLVES:

**Section 1.** That the amount of Two Hundred Twenty Five Thousand Dollars (\$225,000) is hereby appropriated as a contribution from Alaska Center for the Performing Arts (ACPA) to the Areawide General Capital Improvement Program Fund (401) as the required local match to a State Municipal Capital Project Matching Grant Program (AS 37.06) grant of \$525,000 for improvements to the Voth Rehearsal Hall.

**Section 2.** That this resolution shall become effective immediately upon passage and approval by the Assembly.

SUBJECT: Assembly Resolution 2002-113 appropriating \$225,000 from Alaska Center for the Performing Arts to Areawide General CIP Fund (401) for improvements to the Voth Rehearsal Hall

The attached Assembly Resolution appropriates a contribution of \$225,000 received from Alaska Center for the Performing Arts (ACPA) as the required local match to a State Municipal Capital Project Matching Grant Program (AS 37.06) grant of \$525,000. The previously appropriated grant and the ACPA contribution of the local match will be used exclusively for the completion of the Voth Rehearsal hall.

On November 3, 1998, the Assembly passed the Approved 1999 Capital Improvement Budget/Program (AO 98-153 (S) as amended), which included the ACPA Rehearsal Hall, citing "Other" sources as the local match. On September 26, 2000 the Assembly approved the State Fiscal Year 2002 application for grants under the Municipal Capital Project Matching Grant Program, including the ACPA Rehearsal Hall for a \$525,000, 70% grant. On July 24, 2001, the Assembly approved a resolution accepting and appropriating State Legislative Grants and agreeing to provide the required 30% local match.

THE ADMINISTRATION RECOMMENDS THAT THE ANCHORAGE ASSEMBLY APPROVE THE ATTACHED RESOLUTION APPROPRIATING \$225,000 RECEIVED FROM ALASKA CENTER FOR THE PERFORMING ARTS TO AREAWIDE CAPITAL IMPROVEMENT PROGRAM FUND (401) FOR IMPROVEMENTS TO THE ACPA VOTH REHEARSAL HALL.
