

7	THE ANCHORAGE ASSEMBLY RESOLVES:

9	Section 1. In accordance with Municipal Code 21.15.133, the Municipality of
10	Anchorage is proposing a street name change for Stewart Drive in the Southfork area of
11	Eagle River. Stewart Drive is a duplication of another street name located within the
12	Chugiak/Eagle River area. In order to reduce confusion, the proposed new street name is
13	Stewart Mountain Drive. For emergency responses, re-naming of Stewart Drive in the
14	Southfork area would eliminate having two Stewart Drives in the same geographic area.
15	Calls to 911 would not be put in jeopardy with response to the wrong location. This street
16	segment is not to be confused with the main thoroughfare of the area, Hiland Road, of
17	which Stewart Mountain Drive is a part.

UBJECT: Assembly Resolution No. AR / , Renaming of Stewart Drive

he Development Services Department recommends approval of the request to change the name of Stewart rive to Stewart Mountain Drive.

he Municipality is working on the addressing project in the South Fork Community Council area. One hase of this project is to clear up street name problems, including roads names that are duplicates of other reet names within the Municipality.

his street name alteration will rename a street that is a duplicate name of another roadway within the hugiak/Eagle River area. The street in question is Stewart Drive, a quarter-mile stretch road that is part of e Hiland Road alignment. Please see accompanying map. This stretch was officially recorded as Stewart rive in 1971 (Plat 71-193).

ince another street by the name of "Stewart" existed in Eagle River area prior to 1971, the name Stewart rive is not unique, and leads to confusion in site location during times of emergency. Renaming this tewart Drive would present more of a hardship because of the existing addresses at this location. The tewart Drive in the Southfork area is in the process of having site addresses assigned and the changing of ne street name to Stewart Mountain Drive would create a unique street name for which these new site ddresses could be assigned.

he Development Services Department has sent letters of this proposal to all the affected property owners onting the street. The comment period will end on the 15th of May 2002. The Southfork Community ouncil supports the renaming, as does the Southfork Eagle River Volunteer Fire Department. We've also eceived requests from the Anchorage Police Department to rename this Stewart Drive because of the onfusion it causes.

HEREFORE, THE DEVELOPMENT SERVICES DEPARTMENT IS ASKING FOR ASSEMBLY UPPORT FOR THE PROPOSED STREET NAME CHANGE OF STEWART DRIVE TO STEWART MOUNTAIN DRIVE.
