A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING SIXTEEN THOUSAND, FOUR HUNDRED AND FIFTY DOLLARS (\$16,450) OF REIMBURSED REVENUES TO THE AREAWIDE GENERAL FUND (101), OFFICE OF THE MAYOR, FOR A \$10,000 GRANT TO BRIDGE BUILDERS OF ANCHORAGE AND \$6,450 FOR OTHER COMMUNITY PROMOTIONS.

THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1. That the sum of TEN THOUSAND DOLLARS (\$10,000) is hereby appropriated to the Areawide General Fund (101), Office of the Mayor, as a grant to Bridge Builders of Anchorage.

Section 2. That the sum of SIX THOUSAND, FOUR HUNDRED AND FIFTY DOLLARS (\$6,450) is hereby appropriated to the Areawide General Fund (101), Office of the Mayor, for Community Promotions.

Section 3. This resolution shall take effect immediately upon passage and approval by the Anchorage Municipal Assembly.


