In 2001, the Campbell Airstrip LRSA used \$47,261 of its budget to provide park maintenance in the area. To date, \$15,000 of these costs have been reimbursed, with the balance of \$32,261 remaining. During the 2002 1st Quarter Budget Revision process, substantial support from the Assembly to provide for reimbursement was proposed but, ultimately, vetoed and not overridden. SUBJECT: Veto of Assembly Resolution No. 2002-194: "A Resolution of the Anchorage

Municipal Assembly Revising the 2002 General Government Operating Budget by Appropriating the Sum of \$32,260 from the Anchorage Parks and Recreation Service Area to the Street Maintenance Department to

Reimburse the Campbell Airstrip LRSA for Park Maintenance."

I hereby veto Assembly Resolution No. 2002-194 referenced above. I have vetoed that Resolution because the Resolution illegally appropriates funds from one service area to another that exceed a reasonably proportionate share of the costs to maintain Campbell Airstrip Road, a portion of which is within the Far North Bicentennial Park.

The appropriate course of action to correct this problem, as outlined below, is being pursued by the Administration:

- 1. Present to the voters in the Campbell Airstrip Limited Road Service Area (LRSA), the Anchorage Parks and Recreation Service Area and the Anchorage Roads & Drainage Service Area a ballot proposition to change the boundaries of the LRSA to remove Campbell Airstrip Road in Far North Bicentennial Park from the LRSA and the Parks and Recreation Service Area and place it in the Anchorage Roads & Drainage Service Area. The effect of this action would place the costs of maintaining the Park road in the Anchorage Roads and Drainage Service Area, but maintain the road as part of the Park. The proposition will require the approval of a separate majority of those voting on the question within each of the service areas.
- 2. Platting the existing Campbell Airstrip Road with an 80' right-of-way easement.

3. The Anchorage Parks and Recreation Service Area will maintain Campbell Airstrip Road within Far North Bicentennial Park for the balance of 2002 proportionate to its share.
