WHEREAS, during this period the property was taxed based upon mill rate for tax district 43, and

WHEREAS, during this period the property was receiving services which should have placed it in tax district 16, and

WHEREAS, this incorrect listing constitutes a manifest clerical error, and

WHEREAS, Alaska Statute 29.45.500 (c) allows a governing body to correct manifest clerical errors at any time, and

WHEREAS, the refund for the tax year involved totals \$279.60 plus interest at 8 percent per annum to the date of payment.

Ian W. Moore and Jennifer A. Joliff were the owners of record of Real Property Accounts 041-091-42 and 041-091-44 during the period beginning January 1, 1999 through January 1, 2000. In 1998 these two parcels were listed as receiving services that placed them in tax district 43. In fact, these parcels were receiving services that should have placed them in tax district 15. This incorrect listing constitutes a manifest clerical error.

Alaska Statute 29.45.500 (c) allows a "governing body to correct manifest clerical errors at any time.

If the Assembly passes this resolution, a refund of the taxes that were over-paid from 1999 through 2000 is warranted. The applicable tax years, property values affected and value adjustments are as follows:
