SUBJECT: Appropriation of Twenty Thousand Dollars (\$20,000) from the areawide general

fund to Employee Relations/Equal Opportunity for the Municipality of Anchorage

Affirmative Action Program

The accompanying resolution revises the 2002 General Operating Budget (101) by appropriating Twenty thousand dollars (\$20,000) from the Areawide General Fund balance to the Employee Relations Department in order to comply with federal regulations in reviewing and updating the Affirmative Action Plan for the Municipality of Anchorage.

At an Assembly work session held May 14th, 2002 it was determined that the Municipality's Affirmative Action Program had not been updated since 1998. Since it is a requirement that this Program be reviewed and updated annually, we are requesting funding of \$20,000 to contract this service out.

Because the Affirmative Action Program is an intricate part of what the Municipality represents it is appropriate that the Municipality of Anchorage provide resources to assist in maintaining compliance with federal law.
