

Assembly Resolution Appropriating Funds from The Anchorage School District for the Improvement of East 64th Avenue, between Burlwood SUBJECT:

Street and Petersburg Street, Project No. 00-28 (\$8,246)

The accompanying resolution appropriates \$8,246 from the Anchorage School District (ASD) Fund to the Anchorage Roads and Service Area Fund (441).

The resolution is necessary to allow Project Management & Engineering (PM&E) to close its account for the construction of East 64th Avenue to local residential standards. The project was constructed at the request of the ASD, for the purpose of satisfying a Planning and Zoning Commission condition precedent to the ASD's requested vacation of the unused Ashwood Street right-of-way. The approval of the vacation request will allow incorporation of a currently non-contiguous playground area into the Polar Elementary School campus.

The construction of the project was completed in October 2001, experiencing a 2% overrun in total cost due to increased replacement of silty foundation soils with classified non-frost-susceptible gravel. This appropriation of ASD funds, of which PM&E is already in receipt, will cover the overrun.

THE ADMINISTRATION RECOMMENDS APPROVAL OF AR NO. 2002-226 APPROPRIATING \$8,246 FOR THE IMPROVEMENT OF EAST 64TH AVENUE, BETWEEN BURLWOOD STREET AND PETERSBURG STREET.
