A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY OPPOSING THE DECISION MADE BY THE U.S. COURT OF APPEALS FOR THE 9<sup>TH</sup> CIRCUIT REGARDING THE PLEDGE OF ALLEGIANCE AND URGING THE REVERSAL OF ITS RULING

WHEREAS, the U.S. Court of Appeals for the 9<sup>th</sup> Circuit has jurisdiction over Alaska and eight other Western states; and

WHEREAS, on June 26, 2002, the U.S. Court of Appeals for the 9<sup>th</sup> Circuit ruled it is unconstitutional to require students to recite the Pledge of Allegiance in school because of the reference to God; and

WHEREAS, in accordance with previous U.S. Supreme Court decisions, public school students cannot be forced to recite the Pledge of Allegiance; and

WHEREAS, Alaska State and local Municipal laws and statutes do not force students to participate in reciting the Pledge of Allegiance; and

WHEREAS, patriotic songs, engravings on U.S. legal tender, and engravings on Federal buildings also contain general references to 'God'.

NOW, THEREFORE, the Anchorage Municipal Assembly resolves that

Section 1: The Assembly opposes the decision made by the U.S. Court of Appeals for the  $9^{th}$  Circuit.

Section 2: The Assembly urges action to assure the reversal of this ruling.
