A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY OPPOSING THE DECISION MADE BY THE U.S. COURT OF APPEALS FOR THE 9TH CIRCUIT REGARDING THE PLEDGE OF **ALLEGIANCE AND URGING THE REVERSAL OF ITS RULING**

WHEREAS, the U.S. Court of Appeals for the 9th Circuit has jurisdiction over Alaska and eight lother Western states: and

WHEREAS, on June 26, 2002, the U.S. Court of Appeals for the 9th Circuit ruled it is 18 unconstitutional to require students to recite the Pledge of Allegiance in school because of the reference to God; and

WHEREAS, in accordance with previous U.S. Supreme Court decisions, public school students 22 cannot be forced to recite the Pledge of Allegiance; and

WHEREAS, Alaska State and local Municipal laws and statutes do not force students to 25 participate in reciting the Pledge of Allegiance; and

WHEREAS, patriotic songs, engravings on U.S. legal tender, and engravings on Federal 28 buildings also contain general references to 'God'.

NOW, THEREFORE, the Anchorage Municipal Assembly resolves that:

Section 1: The Assembly opposes the decision made by the U.S. Court of Appeals for the 33 9th Circuit.

Section 2: The Assembly urges action to assure the reversal of this ruling

Section 3: The Assembly send copies of this resolution to Alaska's Congressmen and encourage them to pursue establishment of a new Court of Appeals for the Northwest states, including 39 Alaska.

Section 4: That this resolution shall take effect immediately upon passage and approval.
