A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING THE SUM OF THIRTY EIGHT THOUSAND EIGHT HUNDRED THIRTY FIVE DOLLARS (\$38,835) FROM THE STATE OF ALASKA, DEPARTMENT OF PUBLIC SAFETY, DIVISION OF ALASKA STATE TROOPERS AND TWELVE THOUSAND NINE HUNDRED FORTY FIVE DOLLARS (\$12,945) AS A CONTRIBUTION FROM THE ANCHORAGE METROPOLITAN POLICE SERVICE AREA FUND (151), 2002 ANCHORAGE POLICE DEPARTMENT OPERATING BUDGET, TO THE STATE CATEGORICAL GRANTS FUND (231) FOR A PRESCRIPTION FRAUD ENFORCEMENT GRANT.


THE ANCHORAGE MUNICIPAL ASSEMBLY RESOLVES:

Section 1. That the sum of THIRTY EIGHT THOUSAND EIGHT HUNDRED THIRTY FIVE DOLLARS (\$38,835), is appropriated from the State of Alaska, Department of Public Safety, Division of Alaska State Troopers, to the State Categorical Grants Fund (231) for Prescription Fraud Enforcement.

Section 2. That the sum of TWELVE THOUSAND NINE HUNDRED FORTY FIVE DOLLARS (\$12,945), is appropriated from the Anchorage Metropolitan Police Service Area Fund (151), 2002 Anchorage Police Department Operating Budget as a contribution to the State Categorical Grants Fund (231).

Section 3. This resolution shall take effect immediately upon passage and approval.

Subject: Appropriation from the State of Alaska, Department of Public Safety, Alaska State Troopers, of a Prescription Fraud Enforcement Grant (\$51,780).

The Municipality of Anchorage has received from the State of Alaska, Department of Public Safety, Alaska State Troopers, a Prescription Fraud Enforcement Grant in the amount of \$38,835.

This grant, as governed by the Anti-Drug Abuse Act of 1988, Public Law 100-690, Title VI, Subtitle C, will be used by the Anchorage Police Department to identify leads, investigate, and make arrests associated with illegal activity involving prescription fraud enforcement.

A special condition of this grant is that the department provides matching funds. The total projected Municipal cost is \$12,945, which has been budgeted in the 2002 Operating Budget. This grant began July 1, 2002 and will end on June 30, 2003.
