A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING ONE HUNDRED FIFTY THOUSAND DOLLARS (\$150,000) AS A GRANT TO THE STATE CATEGORICAL GRANTS FUND (231), DEPARTMENT OF HEALTH & HUMAN SERVICES, FROM THE ALASKA DEPARTMENT OF HEALTH AND SOCIAL SERVICES FOR THE PROVISION OF PERINATAL CASE MANAGEMENT/HEALTHY BABY SERVICES.

THE ANCHORAGE ASSEMBLY RESOLVES:


Section 1. That the sum of One Hundred Fifty Thousand (\$150,000) is appropriated as a grant from the Alaska Department of Health and Social Services to the State Categorical Grants Fund (231), Department of Health & Human Services, for the provision of Perinatal Case Management/Healthy Baby services.

Section 2. This resolution shall take effect immediately upon passage and approval by the Anchorage Municipal Assembly.

Subject: Resolution No. AR 2002-264 , Appropriation of a State of Alaska, Department of Health and Social Services Grant Award for Provision of Perinatal Case Management/Healthy Baby Services

The Department of Health and Human Services has received a grant award from the Alaska Department of Health and Social Services in the amount of One Hundred Fifty Thousand Dollars (\$150,000). The period of the grant is from July 1, 2002 to June 30, 2003. Expenditures are approved from July 1, 2002.

Under the terms of the grant the Municipal Department of Health and Human Services will provide the following services:

- Inform physicians and other agencies in the Municipality of Anchorage of the availability of case management services, the goals of the program, and the procedure to access these services.
- Outreach to Medicaid enrolled pregnant teenagers and women under age 21 and offer case management services to promote optimum birth outcomes.
- Assess and offer case management/case coordination for children birth to 21 years, who are Medicaid eligible and have special needs.
- Provide case management services including nursing health assessments, care plans, and advocacy.
- Maintain written records for each client.
- Submit client data to the Grant Administrator monthly.
