Appropriation of Accrued Interest from LLEBG Grant

In February of 2000, the U.S. Department of Justice, awarded the Municipality of Anchorage a Local Law Enforcement Block Grant in the amount of \$584,319. with the required Municipal match of \$64,924, the total grant program was \$649,243. This grant was used to fund police equipment purchases, officer overtime, and the Sexual Assault Response Team (SART) contract.

One of the conditions of this grant was that all federal funding be placed in an interest bearing account and the accrued interest must be used for police programs and activities. This grant expires on September 30, 2002, the accrued interest of \$31,216 must be appropriated.

The Anchorage Police Department will apply appropriated monies for the purchase of additional equipment for the records management system, an approved grant budgetary expenditure area.
