A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING SEVENTEEN THOUSAND FIVE HUNDRED NINETY DOLLARS (\$17,590) FROM THE ALASKA STATE COUNCIL ON THE ARTS, THIRTY-SEVEN THOUSAND FOUR HUNDRED EIGHTY-FOUR DOLLARS (\$37,484) FROM THE ANCHORAGE MUSEUM ASSOCIATION, EIGHTEEN THOUSAND THREE HUNDRED THIRTY-EIGHT DOLLARS (\$18,338) FROM THE ANCHORAGE MUSEUM FOUNDATION, EIGHT THOUSAND DOLLARS (\$8,000) FROM ANTICIPATED MISCELLANEOUS REVENUES, AND TWENTY THOUSAND THREE HUNDRED FIFTY DOLLARS (\$20,350) AS A CONTRIBUTION FROM THE CY02 MUSEUM OPERATING BUDGET, AREAWIDE GENERAL FUND (101), TO THE STATE CATEGORICAL GRANTS FUND (231), CULTURAL AND RECREATIONAL SERVICES DEPARTMENT, FOR OPERATING SUPPORT AT THE ANCHORAGE MUSEUM OF HISTORY AND ART (\$101,762).

THE ANCHORAGE ASSEMBLY RESOLVES

Section 1. That sums not to exceed SEVENTEEN THOUSAND FIVE HUNDRED NINETY DOLLARS (\$17,590) from a grant awarded by the Alaska State Council on the Arts, THIRTY-SEVEN THOUSAND FOUR HUNDRED EIGHTY-FOUR DOLLARS (\$37,484) from the Anchorage Museum Association, EIGHTEEN THOUSAND THREE HUNDRED THIRTY-EIGHT DOLLARS (\$18,338) from the Anchorage Museum Foundation, EIGHT THOUSAND DOLLARS (\$8,000) from anticipated miscellaneous revenues, and TWENTY THOUSAND THREE HUNDRED FIFTY DOLLARS (\$20,350) as a contribution from the 2002 Operating Budget, Areawide General Fund (101), Cultural and Recreational Services, are appropriated to the State Categorical Grants Fund (231), Cultural and Recreational Services, for Museum operating support.

Section 2. This Resolution shall take effect immediately upon passage and approval.
