WHEREAS, William D. Gifford was hired by the Anchorage Police Department on  
January 1, 1978; and

WHEREAS, during his tenure, he worked in various divisions within the Department  
including Patrol, Property Crimes, Person Crimes, and Resource; and

WHEREAS, he was rewarded for his dedication to the Department as evidenced by  
the promotions he received including Corporal on December 29, 1982, Sergeant on June  
1, 1985, Lieutenant on July 1, 1990 and, ultimately, Captain on June 25, 2001; and

WHEREAS, he was instrumental in establishing the Major Crimes Response Team  
and is recognized in Alaska Superior Court as an expert witness in areas of crime scene  
forensics; and

WHEREAS, the community expresses appreciation to Captain Gifford for his role  
in assisting in the safety and protection of the citizens of Anchorage; and

WHEREAS, after 24 years of service, Captain Gifford retired from the line of duty  
on August 19, 2002.

NOW, THEREFORE, the Anchorage Municipal Assembly resolves that:

is recognized and honored for his 24 years of service to the Anchorage Police  
Department and the citizens of Anchorage.
