A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING THE SUM OF FORTY FOUR THOUSAND SIX DOLLARS (\$44,006) TO THE AREAWIDE GENERAL FUND, HEALTH AND HUMAN SERVICES DEPARTMENT, FROM STATE REVENUES TO MUNICIPALITIES FOR HEALTH FACILITIES AND HOSPITALS FOR THE 2002 DISTRIBUTION TO PROVIDENCE HOSPITAL

THE ANCHORAGE ASSEMBLY RESOLVES


Section 1. That the sum of Forty Four Thousand Six Dollars (\$44,006) is hereby appropriated to the Areawide General Fund, Health and Human Services Department, from State Revenues to Municipalities for health facilities and hospitals for payment to Providence Hospital.

Section 2. This resolution shall be effective immediately upon passage and approval by the Assembly.

SUBJECT: Disposition of State Revenue Received for Providence Hospital

Alaska Statute AS 29.60.120 provides for State Aid to Municipalities for non-profit hospitals. Within the Municipality of Anchorage, Providence Hospital meets the requirements set forth by Alaska Statute for a qualifying hospital. Therefore, our State Revenue Sharing application contained the necessary information to obtain State aid for Providence Hospital.

Providence Hospital qualifies for a maximum of \$303,000, however, since the amount deposited to the State's "miscellaneous service account" is insufficient to pay each municipality's maximum amount, the amounts that are available shall be distributed pro-rata among eligible municipalities or recipients. The Municipality of Anchorage's share for State FY03 is 14.51994% of \$303,000, which is \$43,995 plus \$11 for a prior year adjustment for a total of \$44,006. The following outlines the revenue and expenditure accounts:
