Subject: AR 2002-323, APPROPRIATION OF A COOK INLET TRIBAL COUNCIL, INC. AMENDED GRANT AWARD FOR EMERGENCY ALCOHOL SERVICES IN THE DEPARTMENT OF HEALTH AND HUMAN SERVICES AND AUTHORIZATION TO AMEND THE COMMUNITY SERVICE PATROL CONTRACT WITH ANCHORAGE DOWNTOWN PARTNERSHIP, LTD.

The Department of Health and Human Services has received an amended grant award from Cook Inlet Tribal Council, Inc. (CITC) increasing the original grant award of Seventy-Four Thousand and Five Dollars (\$74,005) by Forty-Three Thousand Dollars (\$43,000) for a total grant award of One Hundred and Seventeen Thousand and Five Dollars (\$117,005). The additional funds (\$43,000) will be appropriated to the Federal Categorical Grants Fund (241) for the grant period of April 18, 2002 to April 17, 2003.

Additionally, the Administration requests authorization to amend and increase the existing Community Service Patrol contract with the Anchorage Downtown Partnership, Ltd. in the amount of Sixty-One Thousand Dollars (\$61,000).

\$40,150 of the grant amendment will be used in conjunction with previously awarded CITC grant funds, \$20,850, for a total of \$61,000 to enhance Community Service Patrol (CSP) services by amending the existing contract with Anchorage Downtown Partnership, Ltd. for an additional CSP van shift (eight hours per day) from October 1, 2002 through March 31, 2003. This additional van shift is in response to an anticipated increase in service demand based on trends from several previous years during this period.

If this CSP contract amendment is approved, it will be the sixth amendment to this contract. The first amendment added staffing during a peak demand period November 1 through December 31, 2001 (\$12,000). The second amendment extended the contract with ADP, Ltd. for 15 months (January 1, 2002 through March 31, 2003) (\$1,216,250). Due to high demand for services, the third, fourth and fifth amendments extended additional staffing in the Transfer Station during the months of April, May and September 2002 in the amount of \$3,100, \$3,100 and \$3,300 respectively.
