A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING TWELVE THOUSAND DOLLARS (\$12,000) AS A SUPPLEMENTAL GRANT TO THE FEDERAL CATEGORICAL GRANTS FUND (241), DEPARTMENT OF HEALTH & HUMAN SERVICES, FROM THE U.S. DEPARTMENT OF HEALTH AND HUMAN SERVICES TO FUND FAMILY PLANNING SERVICES.

THE ANCHORAGE ASSEMBLY RESOLVES

Section 1. That the sum of Twelve Thousand Dollars (\$12,000) is appropriated as a supplemental grant from the U.S. Department of Health and Human Services to the Federal Categorical Grant Fund (241), Department of Health & Human Services, to fund a portion of Family Planning Services.

Section 2. This resolution shall take effect immediately upon passage and approval by the Anchorage Municipal Assembly.

Subject: Appropriation of a U.S. Department of Health and Human Services Supplemental Grant Award for Provision of Family Planning Services

The Municipality of Anchorage has received a supplemental grant award from the U.S. Department of Health and Human Services providing an additional Twelve Thousand Dollars (\$12,000). The attached Resolution requests appropriation of the additional \$12,000 to the Federal Categorical Grants Fund (241) for the Municipality of Anchorage Family Planning Program. This amendment supplements a previous funding agreement that provides a combined total of \$490,261. The period of the basic grant is from July 1, 2002 to June 30, 2003. Expenditures in this supplemental are approved from September 3, 2002.

Under the terms of the supplemental grant the Municipal Department of Health & Human Services will purchase newly available, FDA approved, contraceptives.

The Municipality of Anchorage has been providing family planning services with grant funding since 1969. The focus of the program is to provide low income women the ability to plan the timing and spacing of their children and to prevent teen pregnancies.
