WHEREAS, Assembly re-districting in the fall of 2001 raised legitimate questions regarding the eligibility of those Assembly candidates whose residences were newly included within the redrawn boundaries; and

WHEREAS, it was imperative that this question be resolved before the May 2002 Municipal Assembly Run-Off Election as well as before the August 2002 State Primary; and

WHEREAS, reasonable and competent elected officials, Municipal employees, private attorneys, and citizens differed as to the intent of the Municipal Charter on this matter; and

WHEREAS, it was publicly stated by numerous public officials, including the Assembly Chair, the Municipal Attorney, and the Municipal Clerk that this matter should be decided by the Courts; and

WHEREAS, Robert Hayes, a candidate for Assembly Section 5, Seat I, came forward and petitioned the Superior Court to answer this important and timely question by determining the residency and eligibility of Brian Whittle, another candidate for Assembly Section 5, Seat I.

NOW, THEREFORE, the Anchorage Assembly resolves:

<u>Section 1:</u> That the Superior Court judgment for fees and costs against Mr. Hayes notwithstanding, there shall be no collection of fees, garnishments, or liens levied against Mr. Hayes regarding this matter, now or in the future.

<u>Section 2:</u> That any and all funds collected from Mr. Hayes in association with this matter shall be immediately returned to him or to any account where he is named as owner, signatory, custodian, or trustee.

Section 3: That counsel for the Assembly in this matter is directed to file a satisfaction of judgment with the Superior Court or a motion to amend the judgment to remove the award of fees and costs, whichever in his professional judgment is most appropriate. If the judgment for attorney fees and costs was recorded with the State District Recorder's Office, counsel is directed to record appropriate documentation consistent with the intent of this resolution.
