A RESOLUTION ADOPTING THE 2003-2008 HOUSING AND COMMUNITY DEVELOPMENT CONSOLIDATED PLAN OF THE MUNICIPALITY OF ANCHORAGE, WHICH CONSTITUTES THE APPLICATION TO THE U. S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT FOR THE COMMUNITY DEVELOPMENT BLOCK GRANT, THE HOME INVESTMENT PARTNERSHIP GRANT AND THE EMERGENCY SHELTER GRANT.

WHEREAS, the Municipality of Anchorage has conducted extensive research and analysis to compile the 2003-2008 Housing and Community Development Consolidated Plan, which is the basis upon which housing and community development needs of lower income residents and neighborhoods are addressed; and

WHEREAS, the 2003 Action Plan comprises the Municipality's five-year strategy for the use of U. S. Department of Housing and Urban Development entitlement funds the Community Development Block Grant, Home Investment Partnership Grant and Emergency Shelter Grant; and

WHEREAS, the Consolidated Plan examines the housing, homelessness, public housing, and non-housing community development needs of the Municipality, prioritizes them, and offers strategies to address them; and

WHEREAS, throughout the development of said Consolidated Plan, the Municipality of Anchorage actively sought participation of residents and representatives of lower income Anchorage neighborhoods, including community councils; and

WHEREAS, public testimony on said Consolidated Plan was heard before the Housing & Neighborhood Development Commission on September 11, and will be heard October 9, 2002; and


WHEREAS, the Consolidated Plan will be endorsed by resolution of the Housing & Neighborhood Development Commission on October 9, 2002.

NOW, THEREFORE, the Anchorage Assembly Resolves:

Section 1. The Assembly adopts the 2003-2008 Housing and Community Development Consolidated Plan as the general basis for a comprehensive approach to address the housing and community development needs of lower income residents and neighborhoods and the application for applicable federal grants.

4 Community Development Consolidated Plan of the Municipality of

7 The purpose of the attached resolution is to adopt the 2003-2008 Housing and
8 Community Development Consolidated Plan. The Consolidated Plan constitutes the
9 Municipality's five-year strategy for the use of HUD entitlement funds for Community
10 Development Block Grant (CDBG), HOME Investment Partnership Grant (HOME), and
11 Emergency Shelter Grant (ESG).

13 The Consolidated Plan must be submitted to HUD by November 15, 2002. The plan will
14 become effective January 1, 2003, following HUD's review and approval. The CDBG
15 and HOME grants are managed by the Community Development Division of the
16 Planning Department. The ESG grant is managed by the Department of Health and
17 Human Services.

19 The Consolidated Plan examines the housing, homelessness, public housing, and non-
20 housing community development needs of the Municipality, prioritizes them, and offers
21 strategies to address them. The Housing and Community Development Consolidated
22 Plan was developed by the Community Development Division of the Planning
23 Department in collaboration with the Department of Health and Human Services, the
24 Housing and Neighborhood Development Commission, the U. S. Department of Housing
25 and Urban Development, and other organizations and private citizens. The consulting
26 firm of TONYA, Inc. was contracted for the final production of the plan.

28 Consistent with federal regulations, availability of the draft 2003-2008 Housing and
29 Community Development Consolidated Plan for public comment was noticed through the
30 *Anchorage Daily News*, *Alaska Star*, *The Anchorage Chronicle* and through electronic
31 mailing. Written comments are to be accepted on the plan from September 9 through
32 October 14. A public hearing was held before the Housing and Neighborhood
33 Development Commission on September 11. A second hearing will be held October 9,
34 2002. All comments will be considered in the final draft of the plan and in the Housing
35 and Neighborhood Development Commission recommendation. The final draft of the
36 plan will include summaries of the comments received, together with responses to each
37 comment. The Draft Housing and Community Development Consolidated Plan is
38 attached.
