A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING ONE HUNDRED THOUSAND DOLLARS (\$100,000) FROM THE HERITAGE LAND BANK FUND (221) TO THE HERITAGE LAND BANK CAPITAL IMPROVEMENT FUND (421) FOR APPROVED HLB CAPITAL IMPROVEMENT PROGRAM PROJECTS

WHEREAS, the 2002 Capital Improvement Budget (CIB) was approved October 30, 2001 by the Anchorage Assembly [AO 2001-164(S)]; and

WHEREAS, the Approved 2002 CIB includes \$200,000 for Heritage Land Bank (HLB) capital projects; and

WHEREAS, an additional amount of \$100,000 is needed from the HLB General Fund (221) to complete funding for Survey Requirements and Site Remediation Requirements from the 2002 HLB CIP projects; and

WHEREAS, the third 2002 HLB CIP project (Girdwood Industrial Park Improvements) is not expected to fully expend its current balance and will therefore not need additional funding; and

WHEREAS, there are sufficient funds in the Heritage Land Bank General Fund to support this appropriation for Survey Requirements and Site Remediation Requirements Projects,

NOW THEREFORE, THE ANCHORAGE ASSEMBLY HEREBY RESOLVES

<u>Section 1.</u> That the sum of ONE HUNDRED THOUSAND DOLLARS (\$100,000) is appropriated from the Heritage Land Bank General Fund (221) to the Heritage Land Bank Capital Fund (421) for HLB Capital Improvement Program projects.

Section 2. This resolution shall take effect immediately upon approval by the Assembly.

A Resolution of the Municipality of Anchorage Appropriating One Hundred Thousand Dollars (\$100,000) from the Heritage Land Bank Fund (221) to the Heritage Land Bank

Capital Improvement Fund (421) for approved HLB Capital projects.

The General Government 2002-2007 Capital Improvement Budget/Program (CIB/CIP) was approved by the Assembly on October 30, 2001 per AO 2001-164(S). Included in the approved CIB/CIP were three Heritage Land Bank (HLB) projects, two of which are continuing projects and one slated to begin in 2002. Of the three projects, two are ready for funding appropriation for 2002:

- Survey Requirements for the continual need to provide surveying and platting of HLB properties and preparatory to improvements to HLB parcels (\$75,000)
- Site Remediation Requirements for required environmental site assessment and removal of contaminants that may exist on HLB property (\$25,000)

A third project (Girdwood Industrial Park Improvement) is currently under consideration for future improvements pending final review of a site specific land use study but is not in need of appropriation at this time.

Each of these projects is also included in the current 2002 HLB Work Program and 2003-2007 Five-Year Plan, approved by the Assembly June 25, 2002 (AR 2002-151(S)). The two projects for which this AR is requesting appropriations to the HLB Capital Fund are eligible for HLB funds in accordance with AMC 25.40.035.C., which allows the HLB Fund to be used for improvements to HLB land.

This appropriation request is necessary to timely initiate work on these projects in accordance with the current HLB work program, cited above. Sufficient funds are available in the HLB General Fund (221) to cover this appropriation.

THE ADMINISTRATION RECOMMENDS APPROVAL OF THIS APPROPRIATION REQUEST.
