THE ADMINISTRATION RECOMMENDS APPROVAL OF ASSEMBLY RESOLUTION NO. 2002-357 AUTHORIZING TAX REFUND DUE TO MANIFEST CLERICAL ERROR.

John and Barbara Trevino have owned this property since May 1999. During an inspection by one of the Property Appraisal Staff in 2002, errors in building size were discovered and corrected that affected value for the tax years 2000, 2001, and 2002. The property record included basement square footage when there was in fact no basement, and first floor building area was overstated. Reduction in property value after correcting this error for 2000, 2001, and 2002 indicate the Trevino's paid excess taxes that should be refunded with interest.
