THE ANCHORAGE ASSEMBLY RESOLVES

Subject: Appropriation of a March of Dimes Supplemental Grant Award for Folic Acid Outreach Project

The Department of Health and Human Services has received a supplemental grant award from the March of Dimes in the amount of Six Thousand Dollars (\$6,000) bringing the total award to Twenty-nine Thousand Dollars (\$29,000). The period of the grant is from February 1, 2002 to January 31, 2003.

These supplemental funds were awarded to provide additional funds to carry out the goal of the folic acid grant: to encourage women of childbearing age to consume at least 400 mcg. of folic acid per day.
