A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY MODIFYING A
CONDITIONAL USE FOR AN ALCOHOLIC BEVERAGES CONDITIONAL USE IN THE B-2B
DISTRICT FOR A BEVERAGE DISPENSARY USE PER AMC 21.40.160D.13, FOR
SORAYA'S LATIN DANCE CLUB, LOCATED ON ANCHORAGE ORIGINAL TOWNSITE,
BLOCK 24A, LOT 5; GENERALLY LOCATED ON THE NORTHWEST CORNER OF WEST
4TH AVENUE AND C STREET

WHEREAS, on April 23, 2002, the Anchorage Municipal Assembly approved a
conditional use in AR 2002-124 for Soraya's Latin Dance Club; and

WHEREAS, Section 3(4) of the conditional use states in relevant part that on-premise
sale of alcohol beverages is limited to the period between 5:00 p.m. Tuesdays through 2:00
a.m. on Sundays; and

WHEREAS, Soraya's Latin Dance Club, due to economic considerations, has requested
a minor modification of the conditional use to extend its hours of on-premise sale until 2:30 a.m.
Tuesday through Friday morning and 3:00 a.m. Saturday and Sunday mornings; and

WHEREAS, the requested modification of hours are permitted by AMC 10.50.010(A)
for this type of licensed business.

NOW, THEREFORE, the Anchorage Municipal Assembly modifies the existing
conditional use for an alcoholic beverage dispensary license in the B-2B District for a Beverage
Dispensary use per AMC 21.40.160D.13, for Soraya's Latin Dance Club, located at the
Northwest Corner of West 4th Avenue and C Street, to extend the hours of on-premise sale of
alcoholic beverages until 2:30 a.m. Tuesday through Friday mornings and 3:00 a.m. Saturday
and Sunday mornings.
