1 A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING FIFTY-FIVE  
2 THOUSAND DOLLARS (\$55,000) FROM THE STATE OF ALASKA DEPARTMENT OF  
3 MILITARY AND VETERANS' AFFAIRS, DIVISION OF EMERGENCY SERVICES (ADES), TO  
4 THE STATE CATEGORICAL GRANT FUND (231) TO SUPPORT ANCHORAGE LOCAL  
5 EMERGENCY PLANNING COMMITTEE (LEPC) ACTIVITIES.

7 WHEREAS, the State of Alaska Department of Military and Veterans' Affairs, Division of Emergency  
8 Services (ADES), in accordance with Agreement #8242 (ADES Obligating Document for Award, State  
9 Fiscal Year 2003) between ADES, the Municipality of Anchorage, and the Anchorage LEPC, has  
10 provided FIFTY-FIVE THOUSAND DOLLARS (\$55,000) to provide State Fiscal Year 2003 partial  
11 funding for the Anchorage LEPC activities for July 1, 2002 through June 30, 2003; and

13 WHEREAS, the Municipality of Anchorage, Office of Emergency Management will provide staff support  
14 for the Anchorage LEPC and accept responsibility of accounting for the expenditures of said monies for  
15 the Anchorage LEPC; now therefore,

17 THE ANCHORAGE ASSEMBLY HEREBY RESOLVES:

19 Section 1. That a grant in the amount of Fifty-Five Thousand Dollars (\$55,000) from the State of Alaska  
20 Department of Military and Veterans' Affairs, Division of Emergency Services (ADES) is appropriated to  
21 the State Categorical Grant Fund 231, for use by the Office of Emergency Management within the  
22 Municipal Manager Department to provide State Fiscal Year 2003 partial funding for Anchorage LEPC  
23 activities July 1, 2002 through June 30, 2003.

25 Section 2. That this resolution shall be effective immediately upon passage by the Anchorage Municipal  
26 Assembly.
